SUBJECT: Abstract of Votes - 2024 City Election

Purpose:

Council to approve the Abstract of Votes Cast in the Precincts of the City of Owatonna during the State General Election held on Tuesday, November 5, 2024.

Background:

The Steele County Property Tax and Election Office prepared the Abstract of Votes from precinct data tapes. The city's ten polling sites were busy on Election Day; 10,087 persons voted and 1,567 new voter registrations were received. The total number of persons voting, 14,418 includes 4,351 absentee/mail ballots received at the county office.

One-hundred and eighteen judges worked at the city's polling sites on Election Day. Eight judges were scheduled to each site at all times during the day and only a few changes were needed. Several Head Judges thought eight judges would be too many, but at the end of the day, many said they could have used another judge to assist with the new voter registration process. Staffing the additional judges allowed voters to move quickly through the polls to cast their votes without waiting in long lines.
